In consideration of the acceptance of my entry: Hospiscare Wild-Tri and Wild-Tri Extreme ('the Event'):

Event Rules and Regulations:

- 1 I agree to comply with the Conditions of Entry, the Event Rules and all regulations laid down by the event organiser Hospiscare.
- 2 I understand that I must meet the cut off times specified on the registration form. Should I fail to complete the Hospiscare Wild-Tri and Wild-Tri Extreme within this time, I will be asked to complete a shorter version of the challenge (this will not include the gorge scramble).
- 3 I confirm that I am aged 18 years or older. If aged 16-18 I have my guardian's consent to register and they will be accompany me on the day of the event.

Possessions and Equipment

- 4 I acknowledge that I have sole responsibility for my personal possessions and athletic equipment during the Wild-Tri and related activities.

IMPORTANT NOTICE - Personal Safety

- 5 I confirm that: I am physically fit and have sufficiently trained for this challenge; and my physical condition has been verified by a licensed medical doctor.
- 6 I acknowledge that a wetsuit will not be provided and you will need to bring your own if you require one.
- 7 I consent to receive any medical treatment which may be deemed advisable in the event of injury, accident and/or illness during the Hospiscare Wild-Tri and Wild-Tri Extreme events.

- 8 Cycling, Running and a Gorge Scramble is an adventure sport and participation in such sports necessarily involves a risk of injury or death regardless of the standard of training, supervision and equipment employed. I voluntarily accept all the risks inherent in the Hospiscare Wild-Tri and Wild-Tri Extreme events and I agree for myself and my personal representatives to indemnify and hold harmless Hospiscare and South West Climb (including without limitation its officers, employees and agents) against any claim or claims whether on my own account or from third parties arising out of any accident or incident resulting in any loss or damage (including bodily injury and death).

Publicity

- 10 I agree to the free use of my name and picture in broadcasts, telecasts, and the press to publicise the Wild-Tri and Wild-Tri Extreme events

The Entry Fee

- 11 I agree that in the event of a race cancellation due to storm, rain, inclement weather, winds or any other Act of God conditions, my entry fee shall be non-refundable.

- 13 I understand that an entry form received by Hospiscare that has not been signed by the participant will not be accepted and will be returned.
