I want Hospiscare to reclaim the tax on my donation(s) and confirm that I have paid at least 25p UK income tax or capital gains tax for each £1 I have donated so Hospiscare will receive 25p for each £1 donated under the Gift Aid scheme. This means for instance that every £10 raised becomes £12.50 – at no extra cost to you! Just think what a difference that can make.

By completing this form you are confirming that:

- You are appointing Hospiscare Shops Ltd to act as an agent on your behalf in attempting to sell or dispose of the goods that you bring into the shop. Where goods are sold, a commission of 1% of the sale price +VAT will be charged for this service and deducted from the proceeds of the sale.
- You own all of the goods that you bring into the shop for sale, you obtained them in a legal manner and you are not acting as a business. You agree that neither Hospiscare Shops Ltd nor Hospiscare will be responsible for any loss or damage to any goods brought into the shop for sale.
- You confirm that Hospiscare Shops Ltd is instructed, as your agent, to donate the net proceeds of the sale of your goods to Hospiscare and that it is not necessary to write to you to confirm the donations, provided that the total value of the net proceeds of the sale of your goods so far in that tax year has not exceeded £1000. Once a sale is made that brings the total value of the net proceeds of sale of your goods to more than £1000 we must first write to you to confirm your consent to those funds over and above the initial £1000 being donated. You may notify us in writing at any time, if you no longer want this agreement to apply.
- You are a UK tax payer and you would like Hospiscare Shops Ltd to make donations to Hospiscare on your behalf and you would like all donations that you make, or have made in the last four years, to be treated as Gift Aid donations (until you notify us otherwise or this agreement is terminated). You can confirm that you have paid at least 25p income tax or capital gains tax in the UK during the applicable tax year for each £1 that you have donated in that tax year. If you pay less income tax and/or capital gains tax than the amount of Gift Aid claimed on all of your donations in that tax year, it is your responsibility to pay the difference. In order to cover the initial £1000 that you have agreed to donate without further notification from us, you must have paid at least £250 income tax or capital gains tax in the UK during this tax year before you sign up to this agreement.
- Any goods which cannot be sold will be recycled where possible and cannot be returned from the date on which you brought them into the shop; Hospiscare Shops Ltd is instructed, as your agent, to transfer ownership of those goods to Hospiscare. We reserve the right to terminate this agreement at any time.
